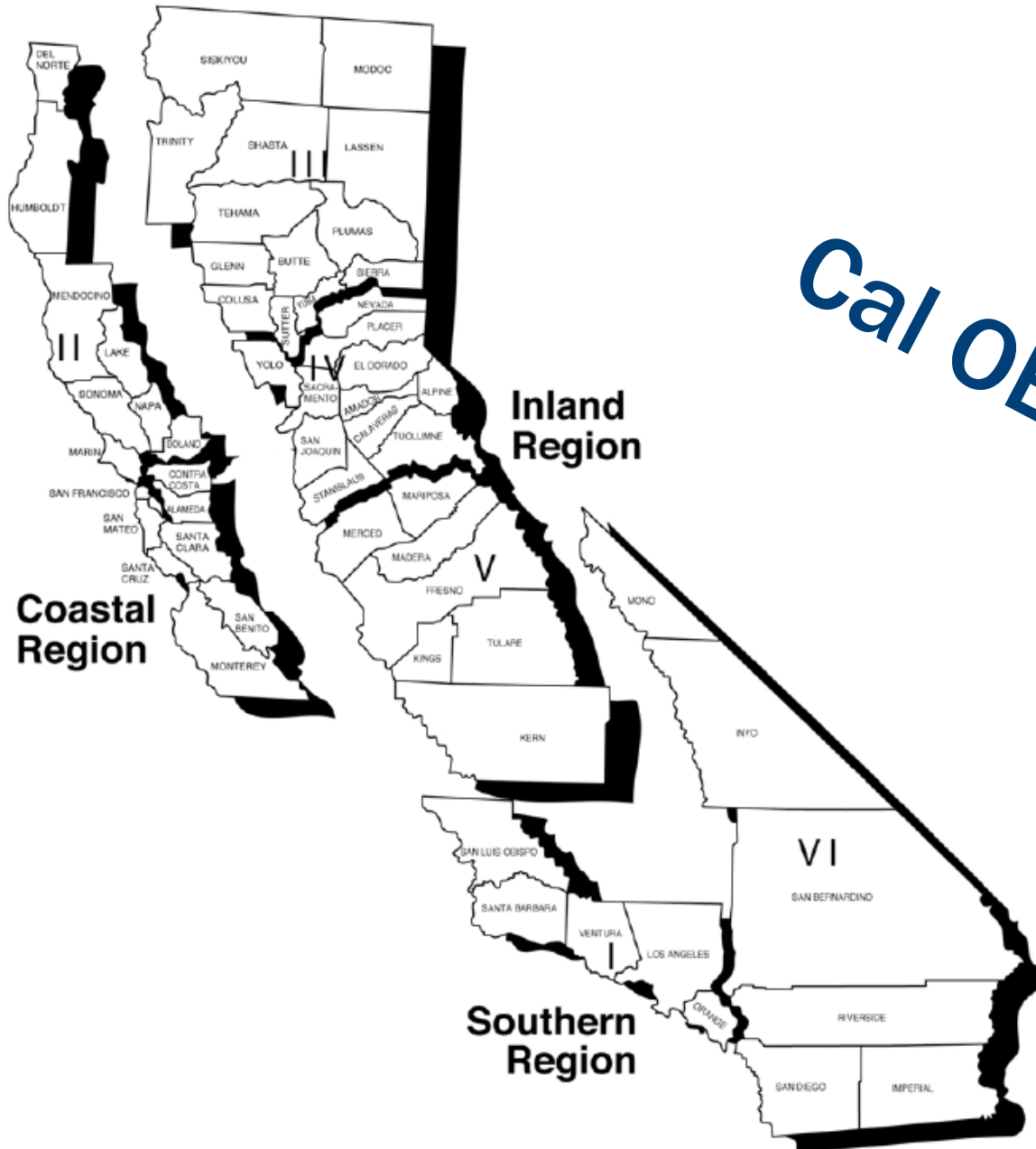

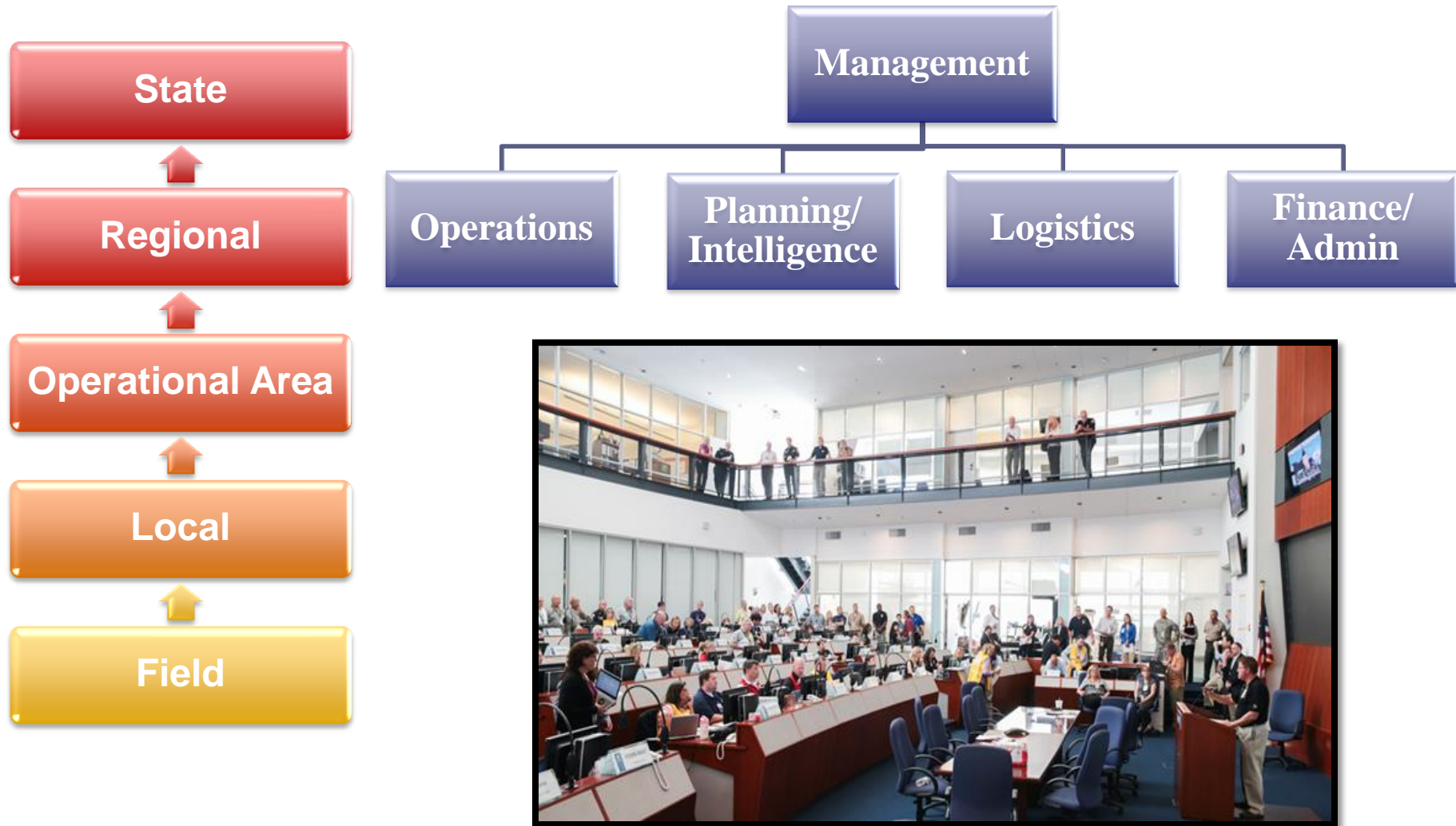

Cal OES Authorities

- California Emergency Services Act, Government Code § 8550 et seq.
- Defines the powers of the Governor and Cal OES during natural, man-made or war-caused emergencies.
- Three Types of Emergency:
 - State of War Emergency
 - State of Emergency
 - Local Emergency

- Resource coordination.
- During major emergencies, may call upon all state agencies to help provide support.

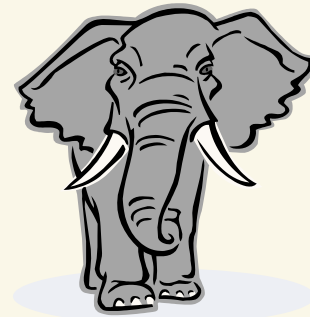
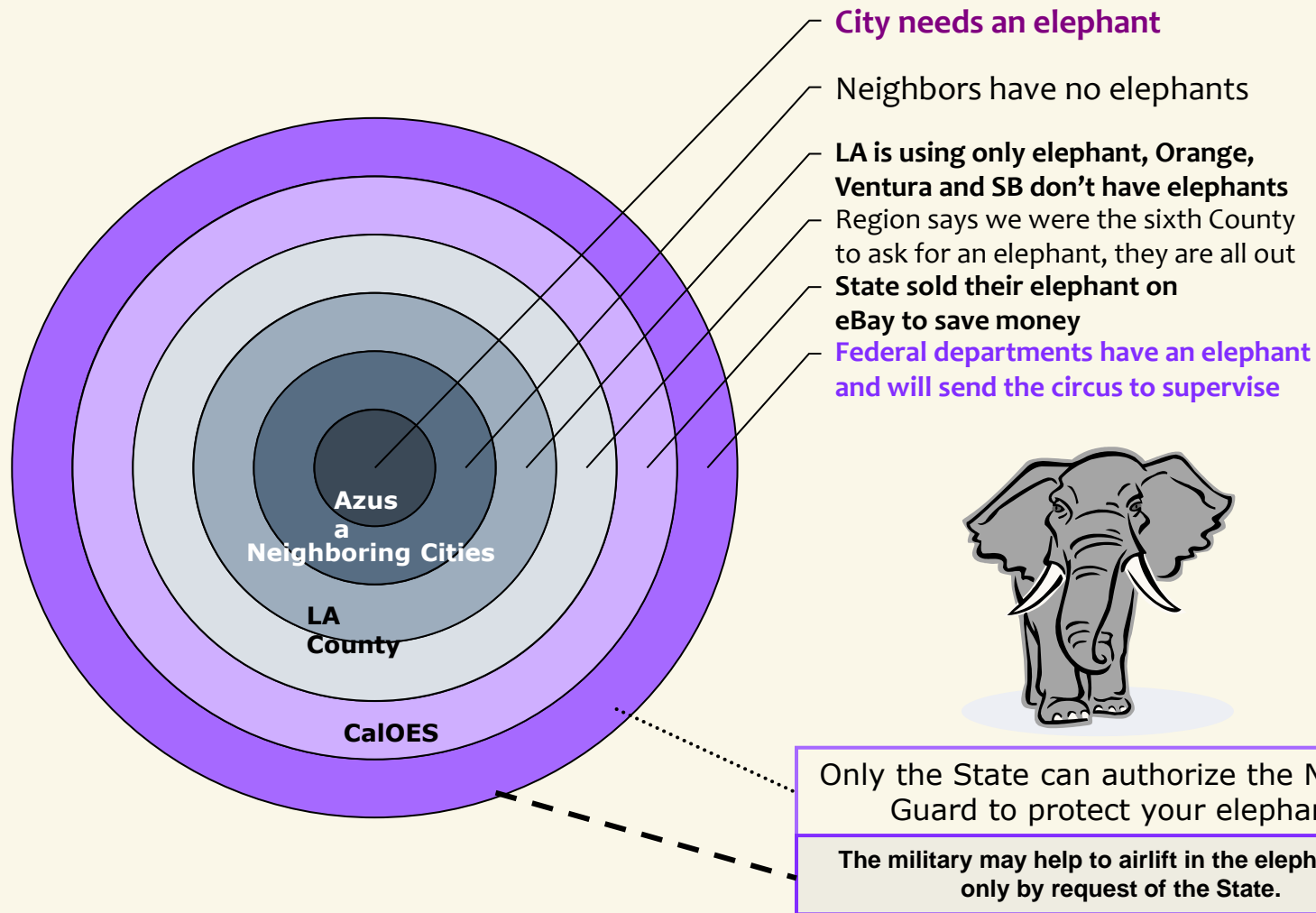

- Activate the **State Operations Center (SOC)** and **Regional Emergency Operations Centers (REOC's)** in support of impacted areas and provide coordinated public messaging.

- **One in 35 people in the US live in LA County**



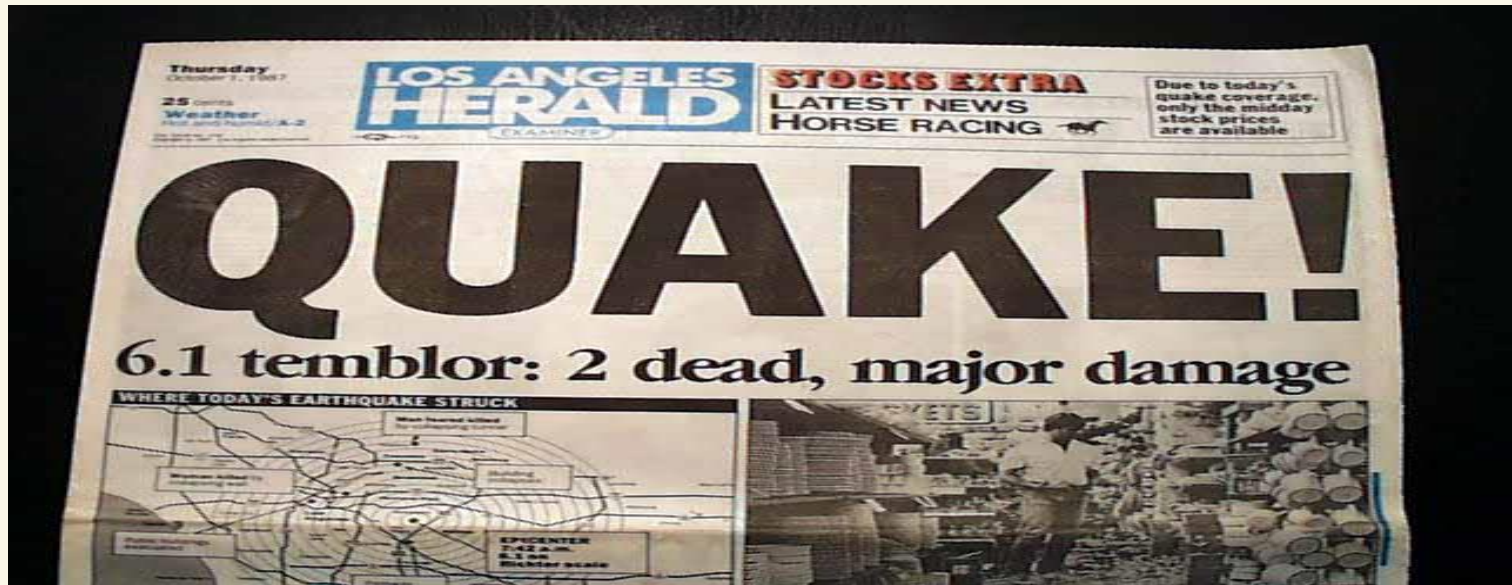

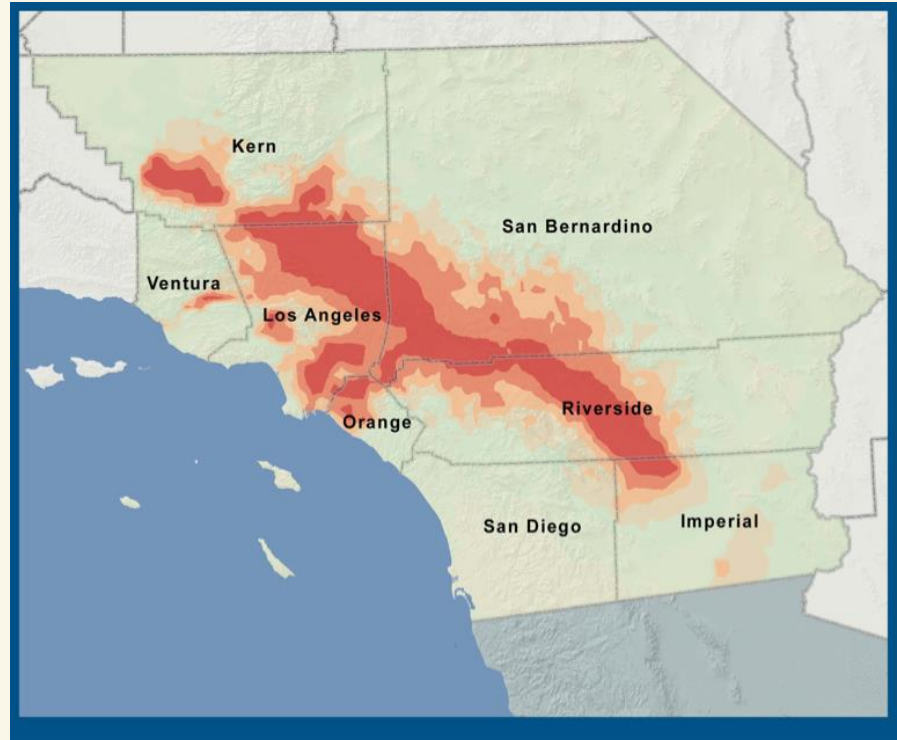
